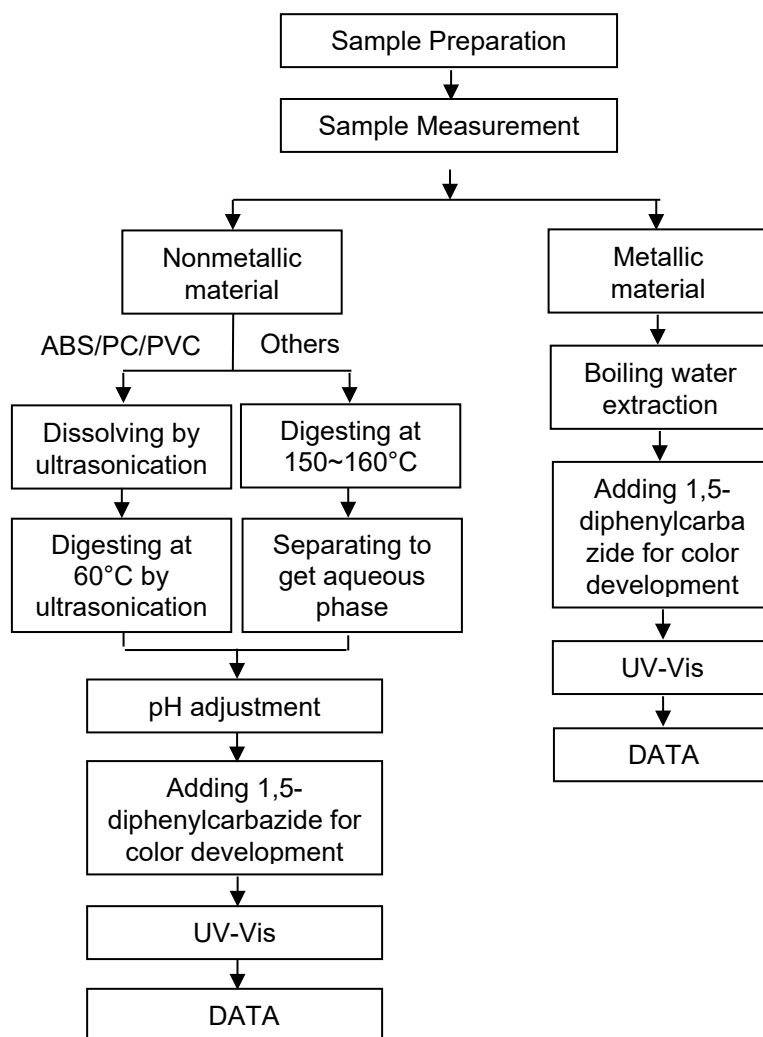

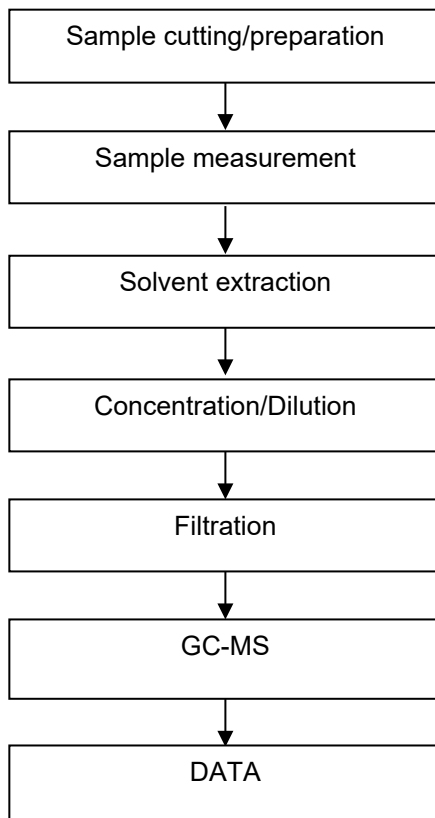

Chlorinated Paraffin Testing Flow Chart



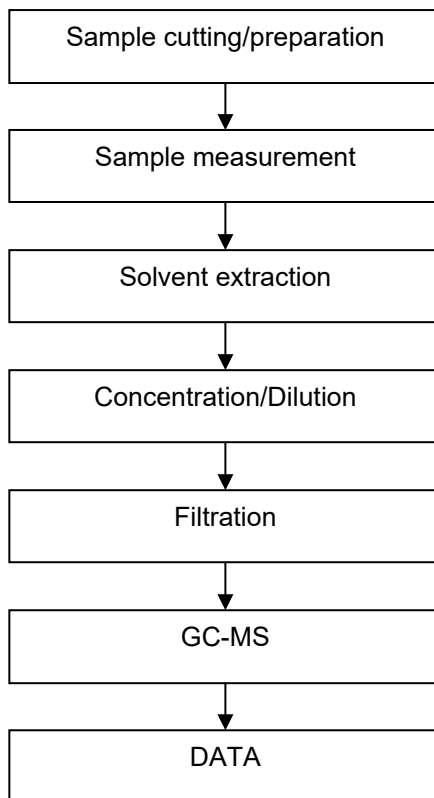

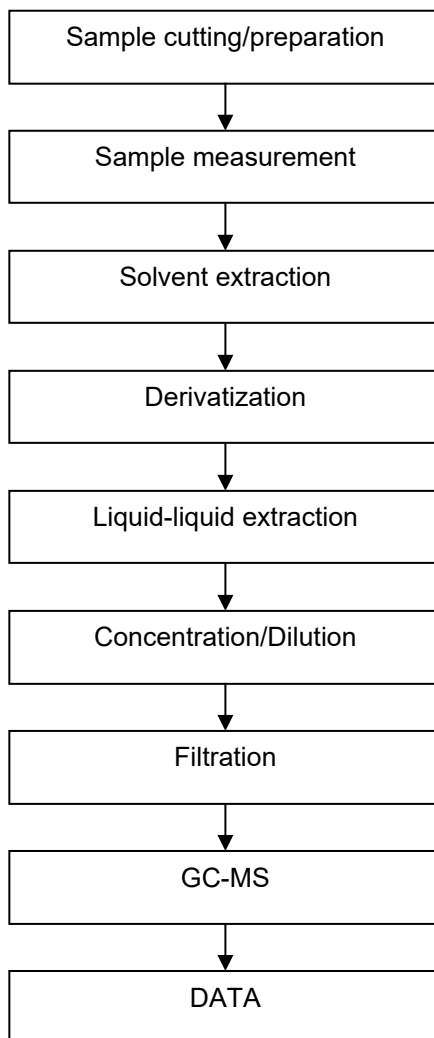

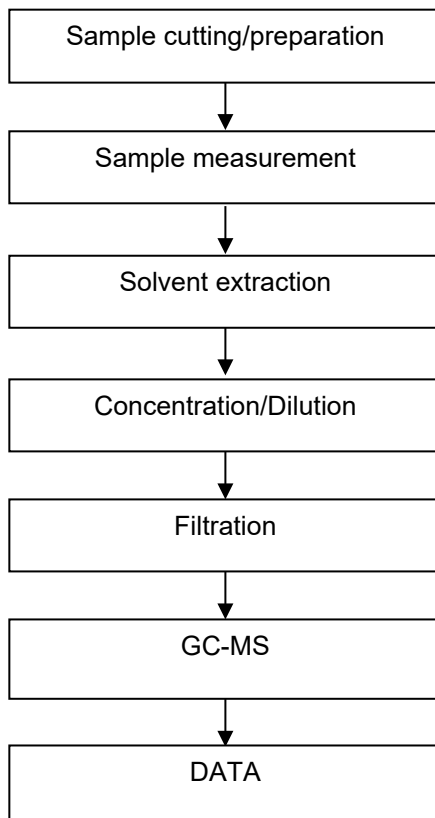

Phthalates Testing Flow Chart



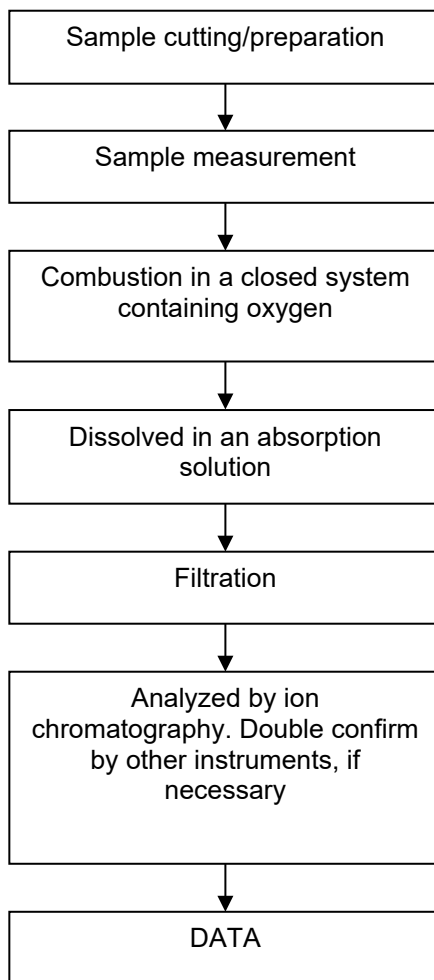

Halogen Testing Flow Chart



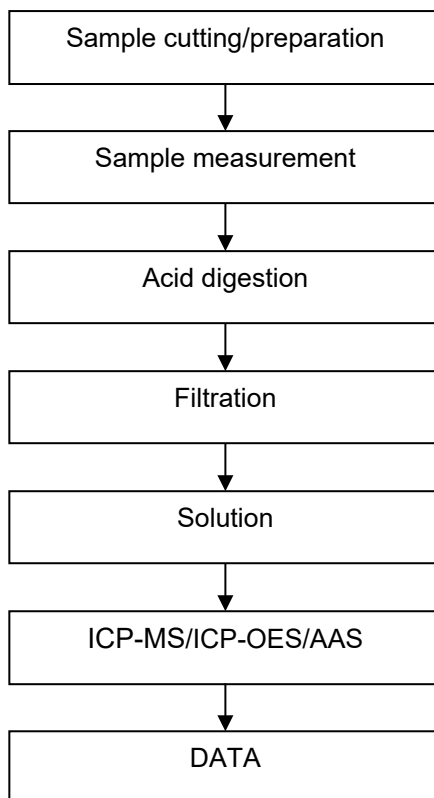

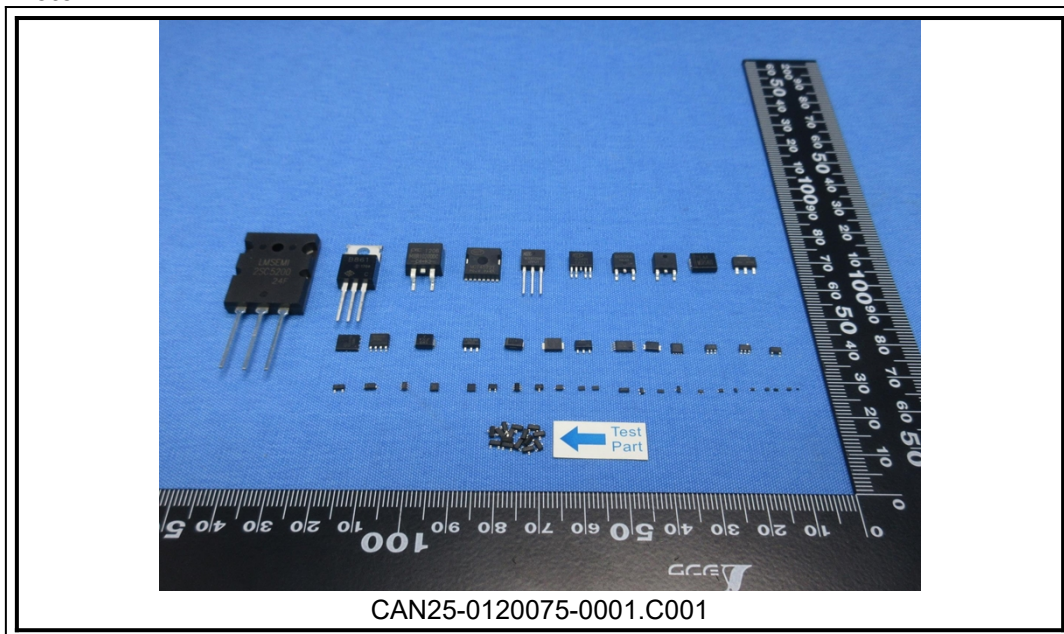
